

Consent to the processing of personal data

1. Privacy is paramount to the Inner Garden Foundation (hereinafter referred to as “Inner Garden”) and an integral, moral and ethical trait of the noble tradition of Alchemy that we pursue. To adequately move with the tide of our digital environment requires due attention for the Personal Data Protection Act (hereinafter referred to as "PDPA."
2. Pursuant to the PDPA, personal data may only be processed if the individual’s personal consent is given. Personal consent is understood to be a voluntary declaration from the data subject that his or her personal data may be processed for a specific purpose (as follows below), which he or she expresses in the context of a communication with Inner Garden, i.e. applying for membership, forum use, enrollment in courses, electronic communication or any other services provided by the foundation. The individual’s voluntary declaration for the above is expressed by ticking the ‘Consent to the processing of personal data’ box on the application form.
3. By providing the requested personal and other data, I declare that I am aware of and agree and expressly authorize Inner Garden to collect and process the data that I have entered in the application form (hereinafter referred to as the “Data”) for the purposes of receiving and processing my membership application, forum application, course application or any other communications, inquiries, services, and statistical analysis of use and/or organizational demographics and composition. Inner Garden may use different communication channels (e.g. telephone, regular mail, e-mail, etc.) to contact or communicate with me. Inner Garden collects and processes the personal data obtained in accordance with the provisions of the law governing the protection of personal data.
4. By checking all the choices and ticking the checkbox “I agree to the processing of personal data”, I declare that I am over 18 years of age and that the information I provide is true and correct.
5. Data to be collected:
 - Contact details (name, surname, telephone number, address, email address);
 - Personal information (formal education/degrees, gender, marital status/children, spoken languages);
 - Medical and social history;
 - Data for the proper assessment of potential students, members and forum participants (esoteric experience, oaths or obligations, interests);
 - Personal Experience and Testimony.
6. I declare that I am aware of and consent to the processing of the personal data I have provided, or the use by Inner Garden of my personal data in its personal data base for the administration of services, complaints, and emails.
7. I declare that I am aware of the fact that I give my personal data voluntarily and without consequences if I refuse, and I am aware of my right to request Inner Garden, in writing or orally, to:
 - allow access to the catalog of the personal data collection in relation to the data I provided and to copy and reproduce them;
 - to confirm whether or not data relating to me is being processed;
 - provide a list of users to whom my personal data has been disclosed, indicating when, on what basis and for what purpose;

- provide information on the sources on which the records contained in the personal data file about me are based, and on the method of processing;
 - to provide information on the purpose of the processing, type of personal data processed and any necessary explanations in this respect;
 - to explain to me the technical or logical-technical decision-making procedures if carried out by automated decision-making by processing my personal data.
8. I declare that I am aware of my right to request Inner Garden, in writing or orally, to complete, rectify, block or erase my personal data which I prove to be incomplete, inaccurate, or collected and processed in breach of the law, and to inform all users of my personal data of any proposed changes before they occur..
